## My “A” Team

His “yeah!” lights up my world! Keivon is a sweet smiling 10 year old boy diagnosed with Huntington’s disease at age 5. He no longer has the ability to speak, but his “yeahs” – the single word he uses to describe how he feels, melts the heart of Patrice, his grandmother and caregiver.

Huntington’s is a genetic disorder, known as ‘the family disease’ because every child has a 50/50 chance of inheriting the gene. It causes the progressive breakdown of nerve cells in the brain and a deterioration of a person’s physical and mental abilities. It has no cure.

Patrice explained, “My grandmother had 10 kids, 5 of them had Huntington’s, one being my mother. My sister had it and her daughter Lakysa, Keivon’s mom, has it.”

Patrice is a woman of strength and faith. She is the primary caregiver for both Keivon and Lakysa, who she adopted when Lakysa was a year old. But, she is not alone in her challenging journey of caregiving – she has her “A” Team – her daughters, son, godmother, and the Hospice Buffalo Essential Care team for Keivon and Home Connections team for Lakysa.

Keivon was an Essential Care for Children (EC) palliative care patient for two years before transitioning just a few months ago into the Essential Care hospice program. His pediatrician recommended Essential Care to Patrice as a resource for additional assistance with his care at home. Monthly visits from a pediatric team would help meet Keivon’s growing needs, as well as hers. Mark Schubauer, EC nurse, recognized that they would benefit from Hospice Buffalo’s advanced care and more frequent visits as Keivon’s health began to decline. Patrice said, “I had heard about Hospice as ‘a place they take someone to keep them comfortable.’ I did not want Keivon to leave home, but Mark explained that their team would continue to provide Hospice care right in my home! The weight I had on me just lifted up – all the worrying and frustration taken away. The EC team took care of everything – had doctors in place, equipment ordered and did not leave until everything was done.”

Lakysa, now 27 years old, was diagnosed with Huntington’s in her late teens/early twenties. During a home visit with Keivon, Dr. Chris Kerr, Hospice Buffalo’s chief medical officer, observed Lakysa’s condition. He discussed with Patrice how the Hospice Buffalo Home Connections palliative care program could provide extra support to her and Lakysa. On that day, the Home Connections team became a part of Patrice’s “A” Team. They visit Lakysa once a month to ensure her healthcare needs are being met. In the event Lakysa needs Hospice care, Patrice knows they will keep working with her: “I don’t know when that day is coming, but I know I will have a support system through it.”

“Every employee we’ve met truly cares about us,” Patrice stated. Melissa, our social worker, knows what we need before we do – she knew I had taken a leave of absence from my job and asked how I was getting by. Next thing I know, my electric bill is paid in full! She also surprised me with a voice recorder in a teddy bear she bought for Keivon, so that I could capture his “yeah!” to have as a beautiful memento. A music, massage and art therapist from Hospice’s unique Expressive Therapy program

regularly visits Keivon – his face lights up with the biggest smile when he knows they are coming. You can just see him relax when they are in our home.

I’ve worked in healthcare for many years and you don’t come across special people like the Hospice Buffalo staff. They treat you like family – every single person. Essential Care was a gift from heaven when I needed it most!”

Patrice wants the community to know that although it is hard being a caregiver, you do not have to do it alone: “Hospice Buffalo has a rare breed of people who genuinely care and will go through your journey right beside you. I feel truly blessed! I am so grateful for the care Hospice Buffalo has given Keivon and Lakysa. They help me cope so I can focus on giving them comfort and love.” ■

## Unwavering Support

Hospice Buffalo has been blessed over the past 40 years to be supported by the WNY community. As our program has grown, so has your support. One of our most dedicated donors is Annette Blanchard. Mrs. Blanchard was born and raised in Buffalo and married at a young age to the love of her life, William Blanchard, who passed in October of 2008.

Mrs. Blanchard began her relationship with Hospice Buffalo back in 1980. She was in school and taking a class on death and dying. The concept of hospice came up, and she was told that there was a hospice program right here in Buffalo. Her father had been ill for about five years, and at that time, doctors were not comfortable talking about death and dying. Her father was suffering, and the family was frustrated with the care he was receiving.

Mrs. Blanchard walked up Hospice Buffalo's steps at the original location, Main Street and Hertel Avenue, and met with Charlotte Shedd – Hospice Buffalo's founder. They discussed the family's concerns and hopes for her father. The very next day Dr. Robert A. Milch, Medical Director, was sitting in her living room and talking with her mom and dad. Shortly after, her father was admitted into Hospice care in their home.

At that time, Hospice was run on a complete volunteer basis. The nurses, aides and doctors – everyone who treated her dad – were doing so as volunteers, and the care was remarkable. A hospital bed was placed in the living room, and the family enjoyed another six months where Annette's father was cared for in the intimacy of their home.

On the day her dad passed, they were all together, along with Dr. Milch. It was beautiful and peaceful. Mrs. Blanchard remembered afterward, Dr. Milch and another colleague were concerned about the aftermath of having the medical equipment left as a reminder, so they began to disassemble the bed themselves. As Mrs. Blanchard laughed, she remembered it did not go well, but everyone has their talents – theirs was caregiving.

Mrs. Blanchard was quickly recruited by Charlotte Shedd to help spread the news of the care Hospice provided to help raise awareness and funds to continue this much needed program. Mrs. Blanchard then began her financial support to Hospice Buffalo and has done so consecutively for 39 years.

In 2008, Mrs. Blanchard needed hospice services for her husband, William. He had been sick for a while, but when he decided to discontinue dialysis, she called Hospice. She once again found herself in a living room, with her husband in a hospital bed surrounded by her family. For the next ten days, they shared loving memories. William was a stoic but fun loving individual. When he passed away there was no room for tears or sorrow. Instead, Annette took the opportunity to continue displaying the devotion and love she had for him.

When asked how Hospice Buffalo has changed over the years, Annette said that it has changed mainly in size. She is impressed with how much it has grown and the innovative programs provided to patients and families. She expressed her pride that Hospice Buffalo is considered a premier hospice provider, which other hospices throughout the country look to for guidance.

It is the great support we receive from loyal donors like Annette Blanchard that enables Hospice Buffalo to continue this incredible service right here in Erie County. **Thank you, Western New York!** ■

## A Moment of Gratitude

It was a particularly busy day, but something caught my attention. I am a greeter at the nurses' station/front desk of Hospice Buffalo's Inpatient Unit. Near my desk, just outside the West Herr Comfort Café, is a gratitude tree that presents visitors and employees an opportunity to write and display what they are grateful for. I happened to observe a man wheeling Paul, one of our new respite patients, around the Unit. I stopped for a moment – usually I engage the families, but something told me to pause. As I looked on, the man knelt beside Paul, held his hand and explained the intention of the tree. It became an obviously emotional and special moment – I watched as they embraced each other and cried. I could not hear exactly what they were saying, but I didn't have to. That moment left an indelible impression – the love and devotion between this father and son was incredibly beautiful.

Later that afternoon, Paul's son was once again "wheeling" him around the Unit and down the hallways. He paused in front of every Hospice anniversary mural, reading the history to his father. This gave me an opportunity to chat with them. I learned that Paul loved history, was President and CEO of a successful hydraulic and pneumatic business that his father started in 1946, and that both of his children, Adam and Rebecca, left their careers to move back into the family home in Hamburg to help take care of him. At times,

Paul became emotional while talking. Adam would quickly hold his father's hand, caress his forehead or hug him – not shy about showing affection for him. But, the most important thing I learned about was Paul's devotion and appreciation for his family, his life and his experiences. Paul made his priorities of love and gratitude in life evident in our brief encounter, and clearly, he imparted this to his son.

I told them that I write what I am thankful for every night in a daily gratitude journal. I mentioned that I witnessed their special moment by the gratitude tree, shared my feelings about how they touched me, and asked their permission to write about the experience of meeting them in my journal. At that moment, Adam knelt in front of his father, held his hands, looked him in the eye and said, "See Dad, look at the impact you made on Nancy – just meeting her for the first time. Now imagine the impact you have had on all the lives of the people who knew you during your lifetime. I promise you will never ever be forgotten."

And he won't be. That moment – so simple and yet profound – will stay with me forever. It serves as a reminder of how important it is to remain grateful, regardless of what your circumstance in life may be. I imagine that this past Father's Day was extremely special for Paul and his family. ■


