

### Retirement Announcement



## Why Do I Walk?

Before Christine (Chrissy) met Arthur, her only memory of Hospice was when her grandmother passed away hours after she was brought into hospice care. Today, not only has her outlook on hospice changed, but she has become a true ambassador for Hospice Buffalo.

Chrissy met Arthur Keroack, Jr. in July of 2015, and it seemed to be ‘love at first sight.’ Arthur bought an engagement ring and planned to propose during their vacation, but decided to hold off. He was constantly fatigued and growing concerned about his health – progressive weight loss, frequent nose bleeds, and violent vomiting multiple times per day. Various doctors couldn’t find anything wrong, but Chrissy knew something wasn’t right, so she became his advocate. She showed a new doctor a picture of how healthy Arthur looked when they first met – they finally looked deeper. In June 2017, Arthur was diagnosed with Stage 4 liver cancer.

Witnessing Arthur’s decline and anxiety when repeating his condition to each different visiting nurse from the homecare agency, her sister suggested calling hospice for help. Chrissy said, “Arthur is not ready for hospice – that is where you go to die!”

Shortly after, Chrissy and Arthur decided to meet with a Hospice Buffalo social worker. “By the end of our conversation, we felt a giant weight had been lifted off both our shoulders. We were blown away by the number of people and resources that we would now have access to, guiding us through this difficult time.”



Arthur started Hospice homecare in November 2017, with visits three to four times a week. And when pain was too much to bear, they utilized the Hospice Inpatient Unit (HIU) for 24/7 care. Chrissy said, “Switching to Hospice was the best thing we could have done. When we decided to get married in the middle of winter on December 1, 2017, his nurse actually came to the hotel to treat Arthur!”

Chrissy mentioned that the highlight of Arthur’s week was when his aide, Peggy, visited. “She helped Arthur realize how much he accomplished in his short life. They formed a special bond.”

Peggy recalls, “I would bring Art his favorite French vanilla coffee from Tim Hortons...we laughed and Art would share some of his boyhood memories and stories of his Catholic School days. I always felt gratitude to God for those visits because I could bring a little hope to Art and for a few shining moments, he could relax with some joy and no pain. The deep love and admiration he had for Chrissy is indescribable and an example to all of us.

*What an example of selfless love on both their parts during those final days – and what a sacred privilege for me.”*

Chrissy recalls, “I came home from work one day to find the laundry folded and dishes done. I asked Arthur, ‘Was my sister here today?’ He said, ‘Peggy did all this so you can spend your time with me.’” As tears welled Chrissy said, “Peggy cared about me having as much quality time with Arthur, as she did for him!”


Sadly, Arthur passed away in the HIU on April 28, 2018. Chrissy’s most memorable moment immediately followed: “After Arthur passed, every worker came to say goodbye – many gathered around him in prayer. It was at that moment that I felt extreme comfort – realizing just how many people Arthur had touched during his time at Hospice.”

Two weeks later, Chrissy and twenty-five of her friends and family formed a team for the 2018 Hospice Memorial Walk, raising over \$3,400! Chrissy has continued to support and give-back to Hospice Buffalo ever since. She coordinated meals for our staff and patients’ families during Thanksgiving and Christmas, and helped organize a toy drive for the patients in our Essential Care for Children program.

In July 2019, Chrissy participated in “Pitch Day” at GEICO where she is a litigation examiner. The GEICO Buffalo office was selected to host this competition for Geico staff to pitch their favorite local charity top Corporate GEICO executives. Chrissy shared her Hospice story – awarding \$7,000 to Hospice Buffalo.

“If we didn’t have Hospice, I wouldn’t have had the quality time I did with Arthur. Hospice is not a place to go because you’re dying, but to go to enjoy the time you have left with your loved one.” Chrissy said, “It’s really important to give back to Hospice – everyone will need it someday.” Chrissy would like everyone to know, to not be afraid of the word hospice, but rather, understand there is so much more they can offer. ■
